Report Overview

The APA Division 37 Section on Child Maltreatment is committed to fostering a connected, inclusive, and engaged professional community dedicated to the prevention, assessment, and treatment of child maltreatment. Meaningful member engagement is essential to sustaining our mission and ensuring that section activities reflect the priorities, interests, and needs of our membership.


To this end, the Section Board conducted a brief member survey in October 2025 to gather feedback on members' experiences with the Section, perceptions of current engagement opportunities, and suggestions for strengthening involvement moving forward. The survey was designed to inform board decision-making and to guide future initiatives aimed at enhancing communication, participation, professional development, and community building within the Section on Child Maltreatment.

This report summarizes key findings from the member engagement survey. The results provide valuable insight into what members value most about the Section, perceived gaps or barriers to engagement, and concrete recommendations for improvement. Findings from this survey will be used to support strategic planning efforts and to ensure that the Section continues to evolve in ways that are responsive, equitable, and aligned with member needs.



48.3% of survey respondents are Faculty Members



What field of study are you in/is most relevant to your work?




Best Formats to Review Updates on Child Maltreatment (CM) Information








